After med school at University of Virginia married Vicki Baker and interned at Philadelphia General Hospital, then served in US Public Health Service in Kanakanak Alaska Native Hospital for three years. Twins born on the way to Alaska, two other children later in Rochester, NY. After a pediatric residency there, worked as a family physician in an urban neighborhood health center, then established a private office. Attended Rochester Friends Meeting and eventually became active in NYYM work, including Powell House committee, General Services and prison visitation. Moved to rural primary care practice in Dundee, NY in 1994. Vicki died in 2006. Married Heather Cook in 2008. Now retired from active practice except School Physician in Dundee (retiring this year). In addition to more than 30 plus years of acute healthcare & senior care experience he has experience in corporate formation and earned an MBA in Healthcare Administration from Temple University while working at PENN. He changed fields to become Senior Director of Affiliate Relations & Special Projects as well as the Nursing Home Administrator at Chandler Hall, a Quaker CCRC in Newtown, held subsequent Nursing Home Administrator jobs and immediately prior to his retirement he was the CEO of Friends Home & Village.
