

## Grantee partner responses to current uncertainty

Elizabeth-Bright Side Manor: Doubt that HUD will end 10 yr. authorized subsidies. Many residents rely on Medicaid.

Frances-Pendle Hill: donor funding may go elsewhere. More focus on being a sanctuary for targeted groups.

Hilary- QVS: People were more generous during pandemic. Clearing some personal data on fellows from database. Trouble finding placements when organizations are conserving funds. Will Quakers be in crosshairs due to lawsuit?

Kevin- NYYM: in crisis more people turn to Quakerism, we know how to be a community, a sanctuary, to organize and stand up for justice.

Donna-Adirondack: no federal funding but clients will be impacted if funding cuts for Medicaid, SNAP, LIHEAP.

Erica-Lutheran Settlement: 68% of funding is government, but mostly state, which comes from Federal. Have other sources and endowment.

Bernie-Mercer St Friends: largest Federal grant is family support not food. Will be ok.

Tricia- Witness to Innocence: Benefit cuts will hurt exonerees who have few other sources of support. Funding competition will grow. Death penalty programs shifting to preserving democracy.

Nia-NEYM: uncertainty. Retaliation for lawsuit? MA is #1 state for research grants. Newcomers stay if they feel nurtured.

Elizabeth-Friendsview: Immigrants are afraid to go out, even citizens. Do not have Medicaid.

Tara-Jewish Relief Org: concerns about food funding. Talking to state reps.

Anne-Friends House: grants from state. Neighborhood has lots of Federal workers, seeing sale signs already. Will trickle down to residents who need to support their children. May increase staffing. High anxiety. Skilled nursing has Medicaid.

Renee-Center in the Park: Everyone impacted. PCA gets Federal funds or thru state. Glad they had to find other funding when PCA cut back a few years ago. Senator recommended NfPs get lines of credit to get through lean times ahead. Double down on mission and values.

Emily-Rutgers: systems have not worked for some people for a long time.

Christine-FHKennett: ICE is everywhere in Kennett. Getting legal advice on what to do if they come. All staff are documented. Want to support Ukrainian doctor. Not Medicaid dependent.

Rita-Hickman: Senator Casey got a \$1M grant for them last year but haven't seen funds yet-worried. Gov. got state funds released. Hope that legislature approved Medicaid for personal care.

Chiyo-FV: No federal funds or Medicaid.

Mical-Kindersmile: biggest concern is for the undocumented immigrants.

Starve Poverty: having to buy food for distribution. No direct federal grant but trickle down.

Lauri-Interfaith Caregivers: 75% of Americorp, 25% of agency funding. Had to remove language from grant proposal. Ultimate authority is not government.

Jan-Springpoint: potential impacts on affordable housing communities, healthcare, older adult services. Ripple effect.

Arthur-SCS: no direct funding, but 1/3 of funding originates at federal, via state and county. Have many of the County Older Adult Act funds. Would seriously impact Meals on Wheels and congregate meals. Has not yet talked to board.

Rise-Leslie-watching. create safe spaces, inform clients, revamping food pantry to bring people inside. Choice pantry. Private fundraising. Hospital-Meridian Health -\$10B losses from Medicaid possible.

MaryPat-Connectedly: Was expecting 2 research grants with Penn and Jefferson this Spring, not sure will be funded. Connectedly gets paid to provide subjects.

Livewell-Stefanie: no government funding.

Habitat for Humanity-Kristine: Gets HUD funds through Housing & Community Development- have been granted but not received. Exec Committee met.

JFS Atlantic-Andrea: Bracing for the worst. Had board meeting, created a plan and impact report. Loss of Medicaid would be catastrophic. Early in org history expanded beyond Jewish community to serving all. County AAA doesn't think they'll be affected.

JFCS -Courtney: Anxiety re unknown. Made map of funding streams. No direct Federal \$, but comes through schools. Medicaid and SNAP would be catastrophic.

Abramson Center: Changed strategy in 2023 to focus on case management (sold nursing home, home care) mobile health. Medicare is not enough, seeking other funding sources.

Ayesha-Ujima Friends Center- most direct impact probably will be seen in demand on food pantry.

Rich + Jeff-Center for Hope Hospice- going ahead as usual. Cuts to Medicaid or Medicare hospice benefit would hurt. Would mean more uninsured. Words shouldn't be a barrier to receiving needed services. Never a more important time to be a non-profit.
